BCSD COVID-19 QUARANTINE AND ISOLATION PROTOCOLS FOR STUDENTS INFOGRAPHIC

STUDENT FEELS SICK WITH COVID-19 SYMPTOMS OR HAS A TEMPERATURE OF 100.4 OR HIGHER

STUDENT HAS BEEN IN CLOSE CONTACT WITH SOMEONE WHO HAS TESTED POSITIVE

- STUDENT WILL REPORT TO SCHOOL NURSE.
- The school nurse notifies the Building Administrator & takes student to a designated area in the building.
- The Building Administrator notifies Human Resources & Deputy Superintendent.
- The school nurse contacts the parent or guardian to make arrangements to pick the student up from school. If multiple students are in the same isolation area, students should be at least 3 feet apart & wearing a face mask.
- The Building Administrator obtains the class seating chart, class attendance, a list of students, faculty & staff to determine who had close contact (close contact is defined as 6 feet or less for a period of 15 minutes or more) with the identified student for contact tracing purposes.
- The Department of Public Health contact tracing protocols will be implemented.
- Student stays home & DOES NOT return until he/she has been fever free for 24 hrs without the use of medication per Department of Public Health guidance.
- Quarantine protocols developed based on the Georgia Department of Public Health Administrative Order issued on August 2, 2021, will be followed. https://be08ff78-0575-47cb-bf49-69d88af2f3a4.filesusr.com/ugd/f95886_dee8a7666c334 ee09526e977d52075f5.pdf
 - If a student tests positive, letters will be sent home to notify parents/guardians of close contact with identified student in the classroom. Faculty & staff will be notified via e-mail.
- Standard cleaning protocols for cleaning, sanitizing of the classroom or area where the student was when illness was reported or implemented.

- BUILDING ADMINISTRATION IS NOTIFIED.
- The Building Administrator contacts school nurse. School nurse takes the student to a designated area in the building.
- The Building Administrator notifies Human Resources & Deputy Superintendent.
- The school nurse contacts parent or guardian of identified student to make arrangements to pick the student up from school.
- The Building Administrator obtains the class seating chart, class attendance, a list of students, faculty & staff to determine who had close contact (close contact is defined as 3 feet or less for a period of 15 minutes or more) with the identified student for contact tracing purposes.
- The Department of Public Health contact tracing protocols will be implemented.
- Letters will be sent home to notify parents/guardians of close contact with identified student in the classroom.
 Faculty & staff will be notified via e-mail.

- In the classroom setting, students who are identified as close contacts to a student who is positive for COVID-19 are not required to quarantine if both students are wearing masks and do not develop any symptoms.
- Standard cleaning protocols for cleaning, sanitizing of the classroom or area where the student was when illness was reported or implemented.

Children who are symptomatic should NOT be in school. If your child is sick, please keep them home. Children waiting on the results of a COVID-19 test should NOT report to school. Sending symptomatic children, those who have been exposed and those awaiting test results to school will compromise our ability to keep all students and staff safe.



A CLOSE CONTACT is a person who has been exposed to a person who has tested positive for COVID-19. The most likely candidates are people who live with a positive case, had direct physical contact with a positive case within 3 feet or less of the case for 15 or more minutes, or has provided care at home to someone who has COVID-19.
